

HELPING PATIENTS VOTE FROM YOUR FACILITY

WHAT HAPPENS IF A NEW PATIENT IS ADMITTED TO MY FACILITY AFTER THE REGULAR ABSENTEE DEADLINE?

Patient Voting is a non-partisan organization to help unexpectedly hospitalized patients to vote in an election using emergency absentee ballots. An emergency absentee ballot is available in most states.

The following includes description of Patient Voting, an action plan for hospitals, and options for free customizable resources with your hospital logo/branding.


HOW DOES IT WORK?

EMERGENCY ABSENTEE BALLOTS EXPLAINED

Most people are familiar with regular absentee ballots used for members of the military and college students who know ahead of time that they won't be able to make it to the polls on Election Day. If someone is unexpectedly hospitalized, they likely didn't make arrangements to vote by regular absentee ballot.

Emergency absentee ballots are used when a registered voter realizes that they can't make it to the polls, but it's too late to apply for a regular absentee ballot.

WHAT HAPPENS IF

A NEW PATIENT IS ADMITTED TO MY FACILITY AFTER THE REGULAR ABSENTEE DEADLINE?

There are already guides available online for people who live in nursing homes to vote BEFORE the regular absentee deadline in their state.

However, as we all, sometimes patients who were living independently are admitted to the hospital, and when they are discharged from the hospital are discharged to a skilled nursing facility, LTAC, or acute rehab.

In situations when the patient's arrival to a SNF, LTAC, or rehab occurs between the regular absentee voting deadline and Election Day, they may have already missed the day when all of the other nursing home residents voted in that facility, and now will not be able to vote in person on Election Day.

Emergency absentee voting can help these patients vote after the regular absentee voting deadline.

- A template of information for you to include on your hospital intranet, newsletter, department emails, weekly bulletins, etc.



- Whether your application and ballot can be sent by via electronic, by mail, or in-person varies depending on where you live...




 - ☒ By authorized agent.
 - ☐ By mail. Depending on when you're hospitalized, if you submit your ballot application by mail, it may not arrive in time to the BOE by the required deadline
 - ☐ There is no electronic submission of application/ballots in Alabama
4. Receive ballot
5. Vote!

 - ✓ There are no restrictions on whether or not your authorized agent has to be a family member
 - ✓ There is no deadline to do initially apply for a special needs voting ballot but you should do so with enough time to return your ballot by Nov 3rd 8PM
3. Your agent will receive a special needs envelope, a ballot and a secrecy sleeve to deliver to you to vote. Check <https://www.elections.alaska.gov/Core/AIPEVEvents.php> for addresses. You may handle this process:
 - ✓ By authorized agent.
 - ✗ There is no submission of the application by mail in Alaska.
 - ✗ There is no electronic submission of the application in Alaska.
4. Receive ballot through your authorized agent.
5. Vote!

 - ✓ You can write down a written request and sign it, attesting to your hospitalization.
 - ✓ You can also file a verbal request by calling your local County Recorder's office.
3. Return ballot application to Board of Canvassers by Nov 2nd 4PM. Check <https://azsos.gov/county-election-info> for addresses. You may deliver your ballot application:
 - ✓ By authorized agent, such as a family member.
 - ✓ By calling your local County Recorder's office and filing a verbal request.
 - ⚠ By mail. Depending on when you're hospitalized, if you submit your ballot application by mail, it may not arrive in time to the BOE by the required deadline.
4. Receive ballot. You may have the option of receiving your ballot through a **special election board** that delivers your ballot directly to your hospital bed.
5. Vote!
6. Return completed ballot to your local County Recorder's office by Nov 3rd 5PM via your authorized agent. If you used a special election board, your ballot returning will be automatically handled for you. Check <https://azsos.gov/county-election-info> for addresses.

By authorized agent, such as a family member.



By mail. This is only possible before October 27th. Depending on when you're hospitalized, if you submit your ballot application by mail, it may not arrive in time to the BOE by the required deadline.



By electronic means. This is only possible after October 27th.

5. Vote!

If you are hospitalized between October 27th and November 2nd, you are eligible to vote by following these steps:

1. Check your voter registration at www.patientvoting.com/check
2. Complete a late vote-by-mail ballot application available at <https://www.sos.ca.gov/elections/voter-registration/vote-mail/#late> or on our site.
 - ✓ Under 'statement and authorization' you must select an authorized representative to obtain your ballot and deliver it to you.
 - ✓ The late vote-by-mail application is available in English, Spanish, Chinese, Hindi, Japanese, Khmer, Korean, Tagalog, Thai, Vietnamese.
3. Return ballot application to the county election official by your authorized representative. Their addresses are attached to the late vote-by-mail application.
 - ✓ By authorized representative. "This application must be provided in person to the county elections official by the voter or the voter's representative."
 - ✗ Do not return late vote-by-mail application by mail. There is no electronic submission of application/ballots in Rhode Island
4. Receive ballot and vote!
5. Your authorized representative must return completed ballot to county election official by November 3rd at 8PM.
 - ✓ The late vote-by-mail option applies to health-care workers and family members of hospitalized patients.
 - ✓ No notary or physician affidavit is required in California for hospitalized voters.

 - ✓ Your written request must include your signature, name, and address of residence and indicate that you are unable to vote in person after the last day to mail a ballot.
 - ✓ The written request must also request that the replacement ballot be given to the authorized person as identified by name and address of residence
3. Return ballot application to County Election Office by **Nov 3rd 5PM**. Check <https://www.sos.state.co.us/pubs/elections/Resources/CountyElectionOffices.html> for addresses. You may deliver your ballot application:
 - ✓ By authorized agent, such as a family member. However, a non-family member may also serve as your authorized agent.
 - ✓ By electronic means, such as email.
 - ⚠ By mail. Depending on when you're hospitalized, if you submit your ballot application by mail, it may not arrive in time to the BOE by the required deadline
4. Receive ballot. You can receive your ballot via your agent or, if you do not have an agent, electronically.

 - ✓ By authorized agent, such as a family member. However, your authorized agent is not required to be a family member.
 - ✓ By electronic means, through Delaware's one absentee application system.
 - ⚠ By mail. Depending on when you're hospitalized, if you submit your ballot application by mail, it may not arrive in time to the BOE by the required deadline.
4. Receive ballot. You may receive your ballot through your agent, mail, or electronically (if you indicate that you are sick on your application).
5. Vote!
6. Return completed ballot to Board of Canvassers by **Nov 3rd 8PM** by authorized agent. Check <https://elections.delaware.gov/locations.shtml> for addresses.

 - ! If you are making your request on Election Day itself, you must fill out a separate **Election Day Vote-by-Mail Ballot Delivery Affidavit (Form DS-DE 136)** affirming that you have an emergency keeping you from voting in-person
3. Return ballot application to your county's Supervisor of Elections with sufficient time to return your ballot by **Nov 3rd 7PM**. Check <https://dos.myflorida.com/elections/contacts/supervisor-of-elections/> for addresses. You may deliver your ballot application:
 - ✓ By authorized agent, such as a family member. However, Florida does not mandate that your agent has to be a family member.
 - ! Some counties may allow you to submit your application via a call to your Supervisor of Elections, rather than sending an authorized agent in-person.
 - ✗ There is no submission of applications by mail allowed in Florida.
4. Receive ballot. You may obtain your ballot through your agent or, in some countries, through an in-person team sent by your county's Supervisor of Elections.
5. Vote!
6. Return completed ballot to Board of Canvassers by **Nov 3rd 7PM** by your authorized agent or by mail. Check <https://dos.myflorida.com/elections/contacts/supervisor-of-elections/> for addresses.




